She was responsible for overseeing US-based affordable housing and community development finance portfolios, as well as impact investing work. She sits on the Board of Directors for the Brooklyn Navy Yard and is a member of the Affordable and Multifamily Housing Council of the Urban Land Institute.

Earlier in her career, she served as vice president and project executive at New Boston Fund, a private real estate investment management firm, where she directed master planning, investment and development of over \$300 million in mixed-use projects in Boston. Prior to that, she was director of development for the Codman Square Neighborhood Development Corporation and director of housing and development for the Asian Community Development Corporation, two nonprofit community development corporations in Boston.

Ms. Davis holds Master of Science in Real Estate Development and a Master of City Planning from the Massachusetts Institute of Technology where she was a Harry S. Truman Scholar. She holds a bachelor's degree from the University of Texas at Austin.
